RE: 2025 Commercial Program Updates

PSEG Long Island is happy to announce the 2025 Commercial Efficiency Program (CEP). Below please find the list of applications effective January 1, 2025. We will continue to accept 2024 applications through Friday, January 10, 2025, at 5:00 PM. After this date we will not accept any 2024 applications.

2025 Commercial Program Disadvantaged Community Rebates:

- PSEG Long Island will continue to support Commercial customers located in a Disadvantaged Community ("DAC") For all 2025 Applications submitted on or after January 1, 2025:
 - o All customers located in a "DAC" may be eligible for up to 25% increased rebates
 - Technical Assistance is not included
 - A "Located in a Disadvantaged Community" Dropdown will be a selectable field on the Customer Information tab for all Commercial Workbooks
 - If "Yes" is selected, all rebates will be increased by up to 25% directly in the workbook
 - Please note, all existing project caps still apply
 - Final "DAC" determination will be made by PSEG Long Island

 - o All Lighting Projects must be completed and closing documents submitted by December 1, 2025
- 2025 HVAC Rebate Application Version 1.0
 - o New Measure → Kitchen Demand Ventilation Control
 - \$560/Unit
 - Operating Hour Updates
 - Partial Building Operating Hours updated to emphasize heating hours
 - HVAC Operating Hours → Updates made to Community College, High School, Hospital, Hotel, Large Office, Large Retail, University

- Please note, the changes in operating hours will result in different rebates/savings between the 2025 application and previous versions
- o Baseline Efficiencies
 - Slight updates to EER and IEER baseline values for Air Conditioning and Air Cooled units
- ERV and HRV Hours Inputs
 - Operating Hours per Day and Operating Days per year inputs now required
- 2025 Standard Rebate Application Version 1.0
 - Discontinued Measures → Pool Equipment, Lawn Equipment, Golf Carts
 - Non-Road Forklifts are still eligible for a rebate
- 2025 Refrigeration Application Version 1.0
 - No Major Changes
- 2025 Custom Performance Rebate Application Version 1.0
 - No Major Changes
- 2025 Technical Assistance Rebate Applications (ALL) Version 1.0
 - No Major Changes
 - o TA projects are not eligible for 25% DAC increased rebates
- 2025 Commercial Weatherization Application Version 1.0
 - o No Major Changes
- 2025 Water Heating and Conservation Application Version 1.0
 - No Major Changes
- 2025 Multi-Family Application Version 1.0
 - o Existing Building In-Unit Rebate Increase
 - Existing Building (Non-DAC) → \$4,000/Dwelling Unit
 - Existing Building (DAC) → \$5,000/Dwelling Unit
 - To be eligible, existing fossil fuel must be decommissioned
 - o Required Documents A Building Permit must be submitted for all new construction projects
 - o New Construction Pre-Approval Duration → Project must be completed and closing documents submitted by Building Permit Expiration Date
 - If Building Permit expires, please contact PSEG Long Island to discuss next steps
 - o Existing Building Pre-Approval Duration → Project must be completed and closing documents submitted within 365 days of pre-approval

Please note: Lighting Pre-approvals and Multi-Family New Construction Pre-Approvals have been updated as a result of New York State's New Efficiency New York (NE:NY) and All Electric Buildings Law. PSEG Long Island will provide more information on both NE:NY and the All Electric Building Law at a later date.
