2. Account service address and installation address on receipt must match to receive this rebate.
3. There is a limit of one rebate per year, per residential account.
4. Qualified purchases made as of January 1st 2024 or later are eligible to apply.
5. Please allow up to 8 weeks for delivery of the rebate check.
6. PSEG Long Island is not responsible for any tax liability imposed as a result of rebate payments.
7. PSEG Long Island is not responsible for lost or undeliverable mail or email.
8. PSEG Long Island reserves the right to use the customer rebate to credit accounts in arrears.
9. Electric Vehicle Supply Equipment (EVSE) rated Level 2 chargers must be on the qualified ENERGY STAR® list at time of purchase.
10. By providing a telephone number and email address, you are giving consent to be contacted at that number about matters that are closely related to the utility service.
11. PSEG Long Island will rebate up to the either 100% of the cost of the charger, or up to the eligible rebate amount, whichever amount is less.
