RE: 2021 Home Comfort Program Application Version 2.0 Release

Dear Home Comfort Partners:

PSEG Long Island is pleased to announce the quarterly release of the 2021 Home Comfort rebate application v2.0. Effective April 5, all new project submittals must use the 2.0 application version. The application is now available for download at <https://www.psegliny.com/saveenergyandmoney/homeefficiency/homecomfort/contractors>.

We have increased the rebate level for cold climate air source heat pumps in nearly all categories. For non-income eligible customers, we have increased our whole house ccASHP rebates for oil with no CAC projects (\$1,000/12,000 heating Btu) and all other fuel sources (\$800/12,000 heating Btu). We also increased rebates for partial house projects as well, for partial ducted ccASHP (\$375/12,000 heating Btu) and ductless ccASHP (\$350/12,000 heating Btu). Partial house rebates for ductless non-ccASHP were reduced (\$275/12,000 heating Btu).

PSEG Long Island is extremely focused on helping their income eligible customers. Therefore, application v2.0 has also increased rebates for LMI eligible customers. We have increased LMI whole house rebates for ccASHP \$3,600/12,000 heating Btu (All Other), \$3,800/12,000 heating Btu (oil with no CAC) and \$4,000/12,000 heating Btu (New Construction and Electric Resistance Heating Replacement). To promote these increased rebates for LMI eligible customers, PSEG Long Island will brand this offering as Home Comfort Plus rebates.

Home Comfort Partners will need to become a participating contractor directly with Energy Finance Solutions (EFS)/Slipstream in order to be eligible to extend LMI rebates to income eligible customers and provide potential financing options for eligible projects with the NYSEKDA Green Jobs – Green New York funding. Eligible cold climate ASHP's must be NEEP listed and have a minimum cooling efficiency of 17 SEER (ducted) or 18 SEER (ductless) and heating efficiency HSPF of 10. Rebates will be calculated using the 17 degrees F rated heating capacity. All ducted and ccASHP installations require ACCA Manual J calculations. Integrated controls are required for all ccASHP Whole House and Partial House ducted installations with fossil fuel heating remaining. Preapprovals are still required. Pre and post inspections may be required.

PSEG Long Island offers an electric heat rate which is lower than standard rates, and whole house heat pump projects may be eligible for the rate change. PSEG Long Island reserves the right to apply the customer rebate towards accounts in arrears. The rebate cannot be assigned to the contractor if the PSEGLI account is in arrears.
